Dr David Bynoe is the National Coordinator of the Global Environmental Facility-Small Grants Programme at the United Nations Development Programme Multi-Country Office for Barbados & the OECS. Previously, Dr Bynoe has worked as an Agronomist with the Ministry of Agriculture, Food, Fisheries & Water Resource Management.

He currently sits on the National Climate Change Committee and has served as a member of the United Nations Environmental Programme Scientific and Expert Review Team.





Sergiy Maslichenko is the former Deputy Minister for the Ministry of Energy and Environmental Protection of Ukraine. During his time as Deputy Minister, he led the preparation of Ukraine's Green Energy Transition Strategy to 2050.

In 2020, he founded Climate Finance and CleanTech (CFACT), an investment and analytic platform dedicated to matching a fast-growing Climate Finance industry with business opportunities in CleanTech in Eastern Europe/Ukraine. He previously led the European Bank for Reconstruction and Development work on energy efficiency and renewable in Eastern Europe and has been a Board Director at the Green for Growth Fund.

Dr Joanna Poon is the Head of Built Environment within the College of Science and Engineering at the University of Derby. She is also the lead for the ERDF Low Carbon Project. She is an active researcher and publishes widely in pedagogy in the built environment, construction project management and property investment.

Prior to joining the University, Dr Poon was the Head of Property and Real Estate in the University of Salford.
