



Chevening in Europe 2026

Background

This guidance is for Chevening university partners participating in a one-off nomination process for part-funded Chevening Scholarships for candidates from Europe.

What's new?

The Foreign, Commonwealth and Development Office (FCDO) has secured additional funding to support Chevening Scholarships for citizens of eligible European countries. This funding is expected to support new scholarship awards over at least the next two academic years.

For the 2026/27 academic year only, scholars will be selected through a one-off university nomination process. This approach has been introduced because the funding was confirmed after the standard Chevening application cycle had closed. There are 40-50 part-funded awards available. Chevening will pay universities the cost of scholar tuition fees and a one-off arrival allowance to scholars. Scholars will be expected to self-fund their living expenses.

From 2027/28 onwards, approximately 20 fully funded scholarships are expected to be offered through the usual Chevening application process, with applicants applying directly through the Chevening online application system. Further details will be shared in due course.

This guidance relates only to the one-off nomination process for the 2026/27 cohort.



Eligibility criteria

To be eligible for a Chevening Scholarship, candidates from Europe must meet [the standard Chevening eligibility requirements](#), including:

- Be a citizen of an eligible non-ODA European country (see Annex A).
- Have at least two years' work experience following completion of their first undergraduate degree.
- Not hold British citizenship or dual British citizenship (unless you are a citizen of a British Overseas Territory or hold BN(O) and are applying from Hong Kong).
- Not be an employee, former employee, or direct relative of an employee of the UK Government, the British Council, or a participating UK university where this would make them ineligible under Chevening rules.
- Commit to returning to their home country for a minimum of two years after completing their studies in the UK.

Candidates who have indicated that they intend to remain in the UK after their studies are not eligible for this scholarship.

Course conditions

Candidates must:

- Hold an offer from their nominating university, for an [eligible full-time taught master's course](#) based in the UK and starting in autumn 2026.
- Have already met all academic and English language requirements for entry.
- Have no outstanding offer conditions other than demonstrating affordability or securing funding for their studies.

Chevening does not normally apply a fee cap for eligible courses, with the exception of MBA programmes. For this scheme, the maximum Chevening contribution towards MBA tuition fees is £22,000. We also ask that the established arrangement with university partners to apply a 20% tuition fee discount to all courses continues for the Chevening Europe awards.

Who can be nominated?

We welcome nominations of all candidates who meet our eligibility criteria, course conditions, and [demonstrate leadership potential](#). This includes candidates with refugee status who are resident in non-ODA European countries, as well as candidates who declare a disability. In addition to the standard funding available, candidates who declare a disability to complete their studies will be eligible for additional financial support in line with established Chevening policies.

When making nominations, universities should aim to include candidates from a range of eligible countries. Where only a small number of nominations are submitted, universities are encouraged to include candidates from countries that are typically less well represented in international student applications. This approach supports broader geographic representation across the cohort and may increase the probability of nominated scholars being selected.



Nomination and application process

Step 1: University nominations

Universities are responsible for identifying eligible candidates from their pool of applicants or offer holders. In order to manage application numbers, participating universities are invited to nominate up to a maximum number of candidates (see Annex B).

Universities should:

- Email selected candidates that they have been nominated (see Annex C).
- Submit candidate information to the Chevening Secretariat by Friday 10 July.
- Communicate with candidates throughout the process as required, including sending them the application link and informing them of the outcome of their application.
- Confirm candidate acceptance of any offer with the Chevening Secretariat.
- Confirm scholar arrival in the UK and enrolment on their course.
- Submit invoices to the Chevening Secretariat for tuition fee payments.

Please note that only applicants nominated by a participating partner university will be considered for a scholarship. Applications received without a corresponding university nomination will not be considered.

Step 2: Candidate application

- Upon clicking on the application link, nominated candidates will be asked to complete a form responding to [questions used in the standard application process](#).
- Applicants must confirm their eligibility as part of the application process and consent to their information being shared between the Chevening Secretariat and their nominating university.

Step 3: Assessment and selection

The Chevening Secretariat will:

- Receive and manage applications.
- Assess applications against Chevening selection criteria and with reference to geographical priorities.
- Inform universities of successful, reserve, and unsuccessful candidates.
- Send letter of confirmation of tuition-fee funding to universities.
- Send confirmation of funding to scholar.

Application timeline

The table below sets out the indicative timetable, which remains subject to change.

Further information

Communication and branding

Chevening Europe 26 is being soft launched. There will not be any dedicated communication or promotional assets relating to it. Outline information for candidates is [available online](#).

Participating universities are requested not to proactively communicate about the scheme or the application process. They are asked to use the nomination process to communicate individually with potential candidates.

Information for candidates

Participating universities are asked to direct candidates to [the Chevening website](#) for information. Chevening will not be able to respond to individual applicant enquiries, and any enquiries received will be referred back to the applicant's nominating university.

Scholar experience

Once confirmed, Chevening Europe scholars will receive the same communications and benefits as other Chevening scholars. This includes invitations to Chevening events such as Orientation and Farewell, and access to a designated Programme Officer. They will also have access to the 24/7 wellbeing service available to all Chevening scholars.

As these scholars will not be bound by a standard Chevening client care agreement, Chevening will not be able to provide visa or immigration advice. In these cases, scholars will be directed to their host university for support.



Data sharing and privacy policy

The usual [data sharing and privacy policies](#) apply to Chevening Europe scholars. Candidates will be asked to acknowledge and accept these on submission of their application.

The data sharing policy authorises Chevening to share personal information with participating universities.

Payment and invoicing

Participating universities will issue an invoice to Chevening for the agreed tuition-fee amounts. Universities are requested to send a separate invoice for Europe 26 scholars, and not to combine with any other invoice(s) for the usual fully funded Chevening cohort of scholars.
